**ORDER RESCHEDULING DATE OF ELECTION AND
DATE FOR EMPLOYER TO FILE VOTER LIST**

On June 6, 2023, Sinai Student Workers-UAW (the Petitioner) filed a representation petition with Region 2 of the National Labor Relations Board (the Board) under Section 9(b) of the National Labor Relations Act (the Act) to represent certain employees of the Employer. The Petitioner sought a bargaining unit that includes all Ph.D. graduate students in the Biomedical Sciences, Neuroscience, and dual degree MD/Ph.D. programs who provide research or instructional services.

On September 11, 2024, the Region issued a Decision and Direction of Election (DDE) to the parties. The DDE required that Icahn School of Medicine at Mount Sinai (the Employer) timely file and serve the voter list by Friday, September 13, 2024.

On September 12, 2024, the Employer requested a one business day extension to file the voter list because it was not provided the two business days from the time of the e-service of the DDE, as required by Section 102.67(l) of the Board's Rules and Regulations. The Petitioner did not object to this request, but it declined to waive having the voter list for the full 10 days and requests that the election be postponed by one business day. The Employer does not object to the Petitioner's request.

IT IS HEREBY ORDERED that the election in the above-entitled matter is rescheduled from Wednesday, September 25, 2024, from 10:00 a.m. to 2:00 p.m. and from 3:00 p.m. to 7:00 p.m. to Thursday, **September 26, 2024, from 10:00 a.m. to 2:00 p.m. and from 3:00 p.m. to 7:00 p.m.**

IT IS FURTHER ORDERED that the time for the Employer to file and serve the voter list is rescheduled from Friday, September 13, 2024, to **Monday, September 16, 2024**. To be timely filed and served, the voter list must be *received* by the Regional Director and the parties

by the due date. The list must be accompanied by a certificate of service showing service on all parties and must meet the requirements described in the DDE. **The Region will no longer serve the voter list.**
